Research Interests: My research takes a behavioral approach to strategic management with a focus on understanding and improving corporate conscience. Grounded in stakeholder theory, sensemaking and sensegiving literature, and social evaluations research, I study sociocognitive interactions between firms and stakeholders during decision-making processes. Largely, I focus on three types of decisions: (1) ethical decisions, such as CSR and sustainability, (2) navigating ambiguous decisions, such as strategic reorientation, and (3) recovery from unethical decisions, such as crisis management. To study these topics, I often develop rich, hand-collected and coded datasets and use methodological approaches that include quantitative and qualitative content analysis, experimental vignettes, event studies, and mixed-methods approaches.
